- 3 Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable
- 4 The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 5 The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter -alia , the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as Ind, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last, quarter;
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 6 The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 7 The institution shall make available list of students admitted on its official website.
