#### APPEAL TO ALL MANUU TEACHERS FOR SMOOTH IMPLEMENTAION OF BIO-METRIC ATTENDANCE SYSTEM FROM 1.8.2019

Dear Sir/Madam,

It has been brought to the notice of the University Administration that on 18.7.2019, the MANUU Teachers' Association (MANUUTA) in its last General Body Meeting (GBM) has reportedly adopted a resolution against the introduction of the Bio-Metric attendance system for teachers introduced by the University through its Office Order No. MANUU/ER-I(B)/F.110/2019-20 dated 5th July, 2019.

- In this context, the following points are brought to the notice of all the teaching staff 2. of MANUU posted at Hyderabad and its Satellite Campuses/Institutions located across the country:-
  - That the decision to introduce the Bio-Metric attendance by the University for all the teaching staff is arising out of Performance Audit of UGC-MANUU conducted by the Office of the Comptroller and Auditor General of India vide Audit para No. 79 dated 31.5.2019, in which it was pointed out that there is no proper system exists at MANUU in which the availability of a teacher for at least five hours daily in the University/College as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2010 (para 15.1) could be ascertained.
  - That the introduction of Bio-Metric attendance is also one of the steps taken by the University to improve academic atmosphere in all its campuses. Availability of teachers for two hours or more in a day for tutorials/guidance/mentoring etc. in the department/college concerned not only is expected to help the enrolled students and researchers but also expected to bring constant improvement in Rankings of MANUU.
  - That subsequently, in order to bring improvement in the quality of Teacher Education in the country, the National Council for Teacher Education (NCTE) through its Order No. NCTE-Regl912/26/2019-US (Regulation)-HQ dated 10th July, 2019 has issued a statutory direction to the all Central Universities including MANUU to introduce Bio-Metric attendance for the teachers and students enrolled for all Teacher Educator programmes (M.Ed/B.Ed/D.El.Ed) within 30 days (i.e. 9th August, 2019) to enable the Council to monitoring purpose (Copy enclosed). The NCTE has also directed the University to upload the attendance of students and teachers on the website of the Teacher Education Institutes (TEI) on a weekly basis. Non compliance of the said directions shall lead to withdrawal of recognition of these programmes being conducted by the University at its Department of Education & Trg and 8 CTEs which is not desirable.



- (iv) That MANUU at present is running eight College of Teacher Education (CTEs) in eight States of the country besides the Department of Education & Training. The teaching staff posted at these CTEs and the Department alone constitutes 1/4th of the total sanctioned positions for the University. Therefore, the University has to maintain uniformity in marking mandatory Bio-Metric attendance for all teachers of the University.
- (v) That similar provisions regarding teaching workload/engagement has been stipulated by the AICTE for technical programmes through its Regulations which are mandatory for MANUU for its programmes viz. B.Tech, M.Tech, MBA, Diploma in Engineering.
- (vi) That MANUU is a multi-campus University and is standing on different footing in terms of its geographical spread (15 States) as compared to other Central Universities. Managing these campuses/Institutions at multiple locations is posing day to day challenge to the University Administration in improving quality in the teaching and learning process as envisaged by the Regulations of the statutory bodies concerned i.e.UGC, NCTE and AICTE.
- (vii) That the University has successfully implemented Bio-Metric attendance for all non-teaching staff including Group A Officer with 15th July 2019.
- (viii) That it may be noted that a large number of the teachers have already registered for Bio-Metric system without any reservations.
- 3. On behalf of the University Administration, I am writing to appeal all the teachers of MANUU for extending cooperation for the implementation of Bio-Metric Attendance system for teaching staff in the Main campus of the University at Hyderabad and off campuses/institutions effective from 1st August, 2019 in the larger academic interest of the students and institution.
- 4. Further, the University has decided to appoint one senior faculty member as Coordinator for the implementation of bio-Metric process of teaching staff to sort out the issues or initial hiccups for implementation.



**PUBLIC NOTICE** 

July 10th, 2019

NCTE has been made aware that the attendance of Teacher - Pupils studying in various NCTE recognized programmes, is not being properly monitored by the affiliating bodies / universities, etc. As a result students with less than desirable attendance records have been reportedly allowed to appear in examinations. NCTE is committed towards ensuring quality teacher education and for this purpose directions are hereby issued to all recognized Teacher Education Institutions (hereafter TEIs) to implement a bio-metric attendance system which must accurately capture the presence of students on all working

It is directed, on the basis of powers available under Regulation, 2014, 8(13) read with 8(14) and Section 17 of the NCTE Act, 1993 (please see Annexure), that all recognized TEIs shall strictly follow the below mentioned directives:

- Bio-metric attendance equipment must be installed within 30 days of the issue of this notice to accurately capture the attendance of appointed teaching faculty and each teacher-pupil enrolled for all NCTE recognized programmes offered in each TEI.
- Such record of attendance must be displayed on the website of the TEI always, ii) with updates on a weekly basis, to enable regular monitoring by NCTE designated staff / organization.

Non-compliance in this regard shall merit action for withdrawal of recognition under Section 17 of the NCTE Act, 1993, after following the due procedure laid down

#### Regulation 8(13):

The institution shall maintain records, registers or other documents, which are essential for running an educational institution especially those prescribed under the relevant rules or regulation and norms and standards and guidelines or instructions of the Central or State or Union territory administrations, affiliating or examining bodies.

#### Regulation 8(14)

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

#### Section 17 of the NCTE Act, 1993

Contravention of provisions of the act and consequences thereof

1) Where the Regional Committee is, on its own motion or on any representation received from any person, satisfied that a recognized institution has contravened any of the provisions of this Act, or the rules, regulations, orders made or issued thereunder, or any condition subject to which recognition under sub-section (3) of section 14 or permission under sub-section (3) of section 15 was granted, it may withdraw recognition of such recognized institution, for reasons to be recorded in writing:

Provided that no such order against the recognized institution shall be passed unless a reasonable opportunity of making representation against the proposed order has

been given to such recognized institution:

Provided further that the order withdrawing or refusing recognition passed by the Regional Committee shall come into force only with effect from the end of the academic session next following the date of communication of such order.

- 3. Non-compliance in this regard by the recognised teacher training institutions, shall merit action for withdrawal of recognition under Section 17 of the NCTE Act, 1993, after follow-up the due procedure laid down thereunder.
- 4. If any clarification is required by you in the matter, you may approach to the NCTE HQrs., New Delhi.
