In continuation to our previous letters referred above, it is to state that

1. Maulana Azad National Urdu University is a Central University under the Ministry of Education, Govt. of India and its headquarters is situated in Gachibowli, Hyderabad.
2. As per UGC Guidelines, the administration has decided about re-opening (Offline activities) in a phased manner by adopting all precautionary measures as per SOP.
3. The University is planning to begin the 1st phase of offline activities in January, 2021 allowing upto 50 research scholars to join the campus and stay in the hostels.
4. The University's primary Health Care Centre will extend all the available outpatient treatment facilities to the students and the staff.
5. Further, in case of COVID-19 infection, (if any) student/staff require hospitalization/isolation. You are requested to confirm the extension of health care facility at any nearby Government Hospital so that the needy can be sent to the identified Government Hospital immediately.
6. It may be noted that on the confirmation of your good office, we are planning to reopening (offline activities) in the University.
