- 3. The quotations received in time will be opened by the committee in the presence of Bidders or their representative (not more than one) may be present, if they desire so at the time of opening of quotations.
- 4. The auction will be governed by the following conditions:-

(i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.50,000/- within 3 days of opening of bids by way of Demand Draft in favour of "Maulana Azad National Urdu University, Hyderabad."
