- 4. The bid must mention the specifications as per the **Annexure I or higher**.
- 5. The quantity included in the bid can be increased or decreased at the discretion of the Competent Authority, Maulana Azad National Urdu University Hyderabad.
- 6. The supply of said items has to be made within a period of <u>21 days</u> from the date of receipt of P.O. 0.5% cost of the whole supply for <u>every week</u> as late supply will be deducted from the bill/EMD to the maximum of 10% after which the order will remain cancelled. In case, if the firm supplies inferior quality, the University may at its decision reject the entire material and impose penalty.
- 7. The amount quoted should include all the charges including taxes, transportation, installation, etc.
- 8. All pages of the tender document are to be signed and stamped by the tendering firm and to be attached along with the bids.
- 9. Conditional bids are not accepted.
- 10. If any manufacturing defect is found till one year / warranty period from the date of supply, the firm should replace the part/item on their own cost within one week from the date of such complaint.
- 11. The firm should submit EMD of Rs.16,700/- alongwith the bid in the form of DD drawn from any scheduled bank in favour of MANUU, Hyderabad payable at Hyderabad. Exemption as per GoI norms will be considered on production of valid documentary proof.
- 12. The University reserves all the rights to place the order items wise with the firm quoted L-1 rates. The L-1 will be considered after deducting buy-back rate(s). In case, if two or more number of firms quotes the same rate, the Committee reserves right to place order as per the additional features /services and other inputs as quoted in the bid. In case, if the two or more firms quotes for the same brand & model with same specifications, all such firms (who have quoted same rates / tie) will be required to submit afresh quote for that particular item and the same will be placed before the committee for further recommendations.
- 13. The L-1 firms should submit 10% value of Purchase Order as Performance Guarantee in the form of D.D/Fixed Deposit (Joint Account) / Bank Guarantee in favour of MANUU which will be released after warranty period + 60 days after fulfilling of all tender obligations. Exemption as per GoI norms (if any) will be considered on production of valid documentary proof.
