#### **Terms & Conditions:**

- 1. Price's are to be quoted both in figures and in words. In case of a discrepancy, that the price quoted in words/ lowest will be taken as valid.
- The bidder should be an Original Manufacturer of the Equipment <u>or</u> authorized dealer/distributor of the above items. The authorization letter from OEM / Original Manufacturer specific to this tender <u>failing which the bid will be rejected</u>.
- 3. Incomplete / conditional bids will be rejected.
- 4. The bid must be as per mentioned specifications **Annexure I** or higher.
- 5. The quantity included in the bid can be increased or decreased at the discretion of the Competent Authority, Maulana Azad National Urdu University Hyderabad.

- 6. The supply and installation of the said items has to be made within a period of <u>28 days</u> from the date of receipt of Purchase Order. In case of delay, 0.5% cost of the whole supply for every week as late supply will be deducted from the bill/Performance Guarantee to the maximum of 10% after which the order will be cancelled. In case, if the firm supplies inferior quality, the University may at its decision reject the entire material and impose penalty.
- 7. The amount quoted should include all the charges including GST, transportation, installation, integration etc.
- 8. All pages of the tender document are to be signed and stamped by the tendering firm and to be attached along with the bids.
- 9. The University reserves all the rights to place the order with the firm quoted lowest rates. In case, if two or more number of firms quotes the same rate (i.e. tie), all such firms will be asked to submit afresh quotation to the item(s) only on short notice.
- 10. The firms should submit an EMD of Rs. 15,000/- (Exemption for registering with MSME NSIC, NCCF, Kendriya Bhandar etc as per GoI norms will only be considered on production of documentary proof) in the form of DD from any scheduled bank drawn in favour of MANUU payable at Hyderabad.
- 11. The L-1 firm should submit 10% value of Purchase Order as Performance Guarantee in the form of D.D / Fixed Deposit (Joint Account) / Bank Guarantee from a scheduled bank in favour of MANUU which will be released <u>after 60 days after completion of warranty</u> and after fulfilling of all tender obligations.

- 13. The University reserves all the rights to reject or accept any tender without assigning any reason or cancel or withdraw the tender notice.
