Thereafter, the Vice-Chancellor asked the Registrar to take up the agenda items for discussions.

# 68.1 Confirmation of the Minutes of 67<sup>th</sup> Meeting of the Executive Council held on 26.03.2018

The point raised during the meeting about the status of recovery of wrong pay fixation will be brought to the EC for its consideration in the next Meeting.

## 68.4.1 Consideration of the report of the one Man Inquiry Committee constituted by the University to look into the award of Wi-fi/Wi-Max work through NICSI by Justice A.K.Roopanwal (Retd.)

The EC noted that a three Member Committee under the chairpersonship of Prof. Mohd. Suleman Siddiqui, former Vice Chancellor, Osmania University & former Registrar, MANUU was constituted by the University to look into the installation and purchases of Wi-fi Wi-Max and other issues in January, 2016. The report of the Committee was tabled during the 64th Meeting held on 20.11.2017. After deliberations, the EC resolved that a Committee be constituted to crystallize the charges so that to fix the responsibility for the lapses by the officials involved in these cases. Accordingly, Justice A. K. Roopanwal (Retd.) as one Man Inquiry Committee was appointed by the University in this case, which was ratified in the EC in its 66th Meeting held on 15.2.2018. Justice A. K. Roopanwal (Retd), the One Man Inquiry Committee submitted the report on 24.3.2018. The report was considered by the EC in its 67th Meeting held on 26.3.2018 and the EC was able to take up for discussion on one part of the report relating to award of printing work of SIM for DDE in the said Page **4** of **7** 

EC Meeting. Due to lack of time, the EC decided to take up the other part of the report of the IO regarding the award of tender to NICSI regarding installation of Secured Data Network (Wi-Max/Wi-Fi connectivity) at MANUU Gachibowli Campus, Hyderabad in the year 2013-14 in the next Meeting.

The EC considered the report (dated 24.3.2018) by the one Man Inquiry Committee constituted by the University to look into the award of Wi-fi/Wi-Max through NICSI by Justice A. K. Roopanwal (Retd). ## 68.5.2. Joining of Prof. Sajid Jamal (Professor of Education, AMU) in the post of Controller of Examinations on deputation basis

### 68.5.3 Revision of pay scales of School Teacher of the Central Universities (CUs) having system as their integral part, pursuant to the recommendations of the 7th Central Pay Commission - Regarding

The EC considered and adopted the UGC letter F.No. 11-1/2017 (CU), dated 16th April 2018, extending the revised pay scales under 7th Central Pay Commission to School Teachers working in the MANUU Model Schools subject to the following conditions stipulated therein:-

- i) The recruitment qualifications are at par with Primary Teachers (PRTs/Trained Graduate Teachers & Post Graduate Teachers (PGTs) etc of Kendriya Vidyalaya Sangathan (KVS);
- ii) The teaching load being brought at par with Kendriya Vidyalaya Sangathan (KVS);
- iii) Their nomenclature of the designation of School Teachers should be at par with Kendriya Vidyalaya Sangathan (KVS)

### 68.5.4 Constitution of Screening-cum-Evaluation Committee for CAS promotion of Assistant Professors/ equivalent cadres from one AGP to the other higher AGP as per UGC Regulations, 2010

The EC considered the matter and resolved to authorize the Vice Chancellor to nominate a person to chair the Screening-cum-Evaluation Committee meetings for considering CAS promotion cases of Assistant Professors/equivalent cadres from one AGP to the other higher AGP.

## 68.5.6. Report the Legal Notice dated 12.04.2018 issued to the Members of the Executive Council by the Advocate of Mr.Mohd.Shaheer Zaman, Asst. Professor (under suspension), Polytechnic, Darbhanga

The EC took a very serious note on the Legal Notice dated 12.04.2018 issued to the Members of the Executive Council by the Advocate of Mr.Mohd.Shaheer Zaman, Asst. Professor (under suspension), Polytechnic, Darbhanga. The Registrar invited the attention of the Members to the provisions under Section 39 of the MANUU Act, 1996 (No. 2 of 1997) which reads as under:-

### Section 39 - Protection of Action taken in good faith

No suit or legal proceedings shall lie against any officer or other employee of the University for anything which is in good faith done or intended to be done in pursuance of any of the provisions of the Act, the Statutes or the Ordinances.

The Registrar also invited the attention of the Members that the EC in its 53rd Meeting held on 23.6.2015 in similar matters resolved that the University Standing Counsel shall represent/appear on behalf of the University authorities and Officers who have been made Respondents in the official matters in the Court Cases. The EC after due deliberations, *resolved* to reiterate its earlier decision to the effect that the University Standing Counsel shall represent/appear on behalf of the University authorities and its Members (past or present) and University Officers or employees who have been made parties/respondents in the official matters in the court cases.
