MINUTES OF THE MEETING OF UBA CELL

A meeting of UBA Cell was held on 17th March 2016 (Thursday) at 3.00 pm in IQAC (Internal Quality Assurance Cell) office, MANUU. The following members attended the meeting:

- 2. Prof. Fatima Begum, Dean, School of Education & Training
- 3. Dr Mohd Yousuf Khan, Principal Polytechnic Hyderabad
- 4. Dr Mohammad Fariyad, Programme Coordinator, NSS
- 5. Prof. Mohd. Shahid, Head, Dept. of Social Work/ Nodal Officer UBA Cell

The Nodal Officer submitted that due to last minute exigency, Hon'ble Vice-Chancellor and Chairperson, UBA Cell will not attend the meeting. Prof. S. M. Rahmatullah, Dean, School of Arts & Social Sciences also communicated his inability to attend meeting. Nodal Officer proposed that Prof. P.F. Rahman may kindly preside over the meeting which he kindly agreed.

The following discussion and deliberations took place, and decisions taken:

- 1. Minutes of the consultative meeting of UBA Cell members dated 9th December 2015 were confirmed (Enclosure-1).
- 2. Adoption of Gram Panchayat Narsingi, Rajendranagar Mandal, District Rangareddy, Telangana as UBA Village of MANUU: Nodal Officer submitted that a three member team of UBA cell visited Gram Panchayat Narsingi. They met stakeholders and developed a brief report on profile of Narsingi (Enclosure-2). It was submitted that the Gram Panchayat Narsingi is located at a distance of 8 km (approx.) from MANUU Main Campus, Gachabowli, Hyderbad and has a population of 9449 (Census, 2011). It was decided that though Narsingi is witnessing increasing urbanization but the large concentration of marginalized groups, their acute deprivation amidst prosperity and pathetic educational scenario are key factors for the adoption of this Gram Panchayat. The adoption of Gram Panchayat Narsingi located in the Rajendranagar Mandal of District Rangareddy (Telangana) as UBA Village of MANUU was approved. It was resolved to have long term sustainable intervention in Narsingi and develop a viable village-university interface. It was also resolved to adopted more villages.
- 3. It was deliberated and decided to involve MANUU CTEs (Colleges of Teacher Education) in adoption of villages under UBA. Dean, School of Education & Training assured for the proactive involvement of all the eight CTEs in the adoption of nearby villages and undertaking community development initiatives in the adopted villages. The following was resolved:
 - a. The notification for the adoption of villages under UBA by all CTEs will be issued by the office of Registrar after due approval of the Competent Authority.
 - b. That the Principal of each CTE to be appointed as Coordinator, UBA of the respective CTEs and he shall ensure smooth conduct of UBA activities in the adopted villages in due consultation with Nodal Officer, UBA Cell MANUU & Dean, School of Education & Training.
 - c. That they may adopt a cluster of backward Gram Panchayats as per the MoHRD letter dated 24th August 2015 on Unnat Bharat Abhiyan (Enclosure-3).
- 4. The resolution of UBA cell meeting dated 9th December 2015 on taking Dean, Academics and Director, Centre for Women's Studies as co-opted members of UBA cell approved.

The meeting came to end with vote of thanks to the Chair.
